## Terms of Agreement

1. An initial deposit in the amount of \$100.00 is due upon execution of this contract in Cash, Check, Money order, Credit Card through Paypal, or a Paypal account transfer. Check or Money Order should be payable to **Jorin Rudd**. Any deposit received is non-refundable. The remaining payment must be made in full prior to performance in Cash, Money Order or Cashiers check unless prior arrangements are agreed upon and signed upon by all parties involved. In the event of non-payment prior to the performance, the Purchaser agrees this contract shall be cancelled immediately with no performance required and any previous payments shall be immediately forfeited to the entertainer. In the event of non-payment after the performance, purchaser further agrees to remit any uncollected balance including a ten dollar per statement fee plus reasonable collection or attorneys fees. Purchaser shall be charged \$30 for each returned check plus a \$10 service charge for each collection notice. Past-due balances will incur interest at the rate of 2% for each month in which the balance is outstanding.
2. Parties entering into this contract are permanently bound to fulfill the obligations by this contract unless one or more of the following conditions apply:
  - a. Both parties mutually agree to cancel the contract and its responsibilities.
  - b. The event described herein is completely cancelled, and a minimum of 30 days notice is given.
3. In the event that Jorin Rudd becomes unable to provide his services due to complications beyond his control, acts of God, or accidents, a reputable replacement shall be provided at no more than the original price agreed on. Should Jorin Rudd be unable to procure a qualified replacement, Purchaser shall receive a credit or a full refund of all prepaid fees. Purchaser agrees that in all such circumstances, Jorin Rudd's liability shall be exclusively limited to refunding the fees paid and Jorin Rudd shall not be liable for any indirect or consequential damages arising from any breach of this contract.
4. Hyperformance Audio Productions shall not be held liable for any action arising from or in connection with any individuals not directly affiliated with Hyperformance Audio Productions. Furthermore, the party(s) contacting Hyperformance Audio Productions agrees to assume full responsibility for any and all damages caused by themselves or their guests involving any of Hyperformance Audio Productions property.
5. The parties purchasing the services of Hyperformance Audio Productions agree to provide a secure parking space in a reasonably close proximity to Venue's loading area for Jorin Rudd's vehicle for a period commencing two (2) hours prior to the performance and continuing for one (1) hour following the performance.
6. Sound and Lighting: Hyperformance Audio Productions shall furnish all sound equipment, microphones, extension cords as needed, and lighting effects equipment necessary for the performance. Purchaser agrees to provide access to at least two (2) 3 prong grounded 120v /15 Amp wall plugs. Hyperformance Audio Productions agrees to provide all personnel required to assist the setup, conduct of the performance, and takedown after the performance.
7. We believe in lyrically edited music and will only provide edited music for our performances.
8. Hyperformance Audio Productions agrees to provide proof of insurance to all venues that require it.
